ORDER DECLARING THE 13TH ANNUAL GREATER PORTLAND FESTIVAL OF NATIONS

- **ORDERED,** that Mugadi Foundation is authorized to use Deering Oaks Park on Saturday, July 25, 2015 from 11:00 a.m. 7:00 p.m. to hold its 13th annual free event to the public for music, food, cultural exhibits, children's activities, and folk art from the United States and many nations around the world; and
- **BE IT FURTHER ORDERED**, that the festival area shall include the Bandstand and Farmers Market Road inside Deering Oaks Park, the Ravine Water Play Area and park roadways Tennis Court Road and Jenny Lane, which area will also be closed to street vendors pursuant to Section 19-17 of the Portland City Code and reserved for the use of Mugadi Foundation for the purpose of conducting the festival, subject to the direction and control of the City Manager or Acting City Manager; and
- **BE IT FURTHER ORDERED**, that the main road into Deering Oaks Park will be closed to traffic from 10:00 a.m. to 10:00 p.m. on July 25, 2015; and
- **BE IT FURTHER ORDERED**, that the City Manager or Acting City Manager is authorized to issue a revocable permit under Section 25-27 of the Portland City Code subject to the following conditions:
 - (1) Mugadi Foundation shall indemnify and hold the City, its officers and employees harmless from and against all claims arising out of activities during said event and shall take out and maintain public liability insurance coverage in the amount of at least \$400,000 per occurrence for personal or bodily injury, death, or property damage for said purposes. Mugadi Foundation shall provide the City with a certificate showing evidence of such insurance and this insurance certificate will also list the City of Portland as an additional insured in regard to the Festival of Nations activities; and
 - (2) Under no circumstances may alcoholic beverages be sold or consumed on the streets or public property of said area during said festival; and
 - (3) The following fees and expenses shall be waived by the City and in-kind contributions made by the City to the Festival:

- Public Services: permit fees for use of grounds, banner fees, electricity fee, Staff at setup of festival and festival itself, barricades, trash barrels and removal of trash; and
- (4) The organizer shall pay any City Clerk license fees. No Police or EMS assistance should be necessary unless the Police Department deems coverage is necessary due to attendance, traffic concerns, etc. If police assistance is necessary, Mugadi Foundation is responsible for covering those costs; and
- (5) Conditions for use of grounds, specified in a permit issued from Public Services Event Office, shall be adhered to; and
- (6) Festival of Nations shall leave, on file with Public Services, security deposits for use of the park; and
- (7) Festival of Nations/ Mugadi Foundation shall have sole authority over participating vendors at the event and may charge a fee to vendors for the opportunity to vend at the Festival of Nations; and
- **BE IT FURTHER ORDERED**, that the City Manager or Acting City Manager is also authorized to issue such other temporary licenses, including licenses for food service establishments, as may be required by the Portland City Code, provided that all other applicable requirements of said code have been met regarding the operation of this event.
